Notice is hereby given, pursuant to Section 110 and other applicable provisions of the Companies Act, 2013 (the 'Act') read together with Rule 22 of the Companies (Management and Administration) Rules, 2014 (the 'Rules'), (including any statutory modification or re-enactment thereof for the time being in force), the relevant provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Secretarial Standard – 2 relating to General Meetings and other applicable laws and regulations, to the members of Associated Stone Industries (Kotah) Limited (the 'Company') that the special resolutions appended below is proposed to be passed by way of Postal Ballot including e-voting.

1. To Change name of Company from ASSOCIATED STONE INDUSTRIES (KOTAH) LIMITED to "ASI INDUSTRIES LIMITED".
2. To alter the Name clause of the Memorandum of Association.
3. To alter the Article of Association of the Company.

The proposed resolutions and the Explanatory Statements setting out the material facts concerning these resolutions and the rationale thereof are annexed hereto along with a Postal Ballot Form for your consideration and voting.

The Board of Directors of the Company in its meeting held on Wednesday, **13th December, 2017** has appointed Mr. Prabhat Maheshwari, Partner, GMJ and Associates, Practicing Company Secretaries, Mumbai as the Scrutinizer for conducting the Postal Ballot (physical and e-voting) process in accordance with law and in a fair and transparent manner.

The business of the Postal Ballot shall, in addition to physical voting, also be transacted through electronic voting system. Accordingly, the Company in compliance with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the 'Listing Regulations') and the provisions of Section 108 of the Act read with Rules 20 and 22 of the Rules, as amended from time to time and Secretarial Standard – 2 relating to General Meetings, is pleased to provide to the shareholders, the facility to exercise their right to vote on the matters included in the Notice of the Postal Ballot by electronic means i.e. through e-voting services provided by the Central Depository Services (India) Limited ('CDSL'). The e-voting period commences on **Tuesday, 9th January 2018 at 9.00 a.m. IST and ends on Wednesday, 7th February, 2018 at 5.00 p.m. IST.**

Please read carefully and follow the instructions as printed in this Notice for e-voting.

Those shareholders, who do not have access to e-voting facility can send their assent or dissent in writing on the Postal Ballot Form attached herewith. Shareholders are requested to carefully read the instructions on the Postal Ballot Form and return the Postal Ballot Form duly completed and signed in the attached self-addressed, pre-paid postage envelope, so as to reach the Scrutinizer before 5.00 p.m. IST on **Wednesday, 7th February, 2018.** Please note that any Postal Ballot Form(s) received after the above mentioned period will be treated as not received.

The Scrutinizer will submit his report on the votes polled through E voting/Postal Ballot, to the Chairman or any Director or Company Secretary. The Chairman will or in his absence, any director or Company Secretary, will announce the results of Voting by Postal Ballot on **Friday 9th February 2018 at 5.00 p.m.** and the resolutions will be taken as passed effectively on the date of announcement of the results by Chairman or Director or Company Secretary as the case may be. The Scrutinizer's decision on the validity of the votes cast through E-voting /Postal Ballot shall be final. The Results of the E-voting /Postal Ballot will be displayed at the Registered Office, posted on the Website of the Company www.asistone.com and intimated to the Stock Exchange on which the shares of the Company are listed.

ITEM NO.1 to 3

THE ASSOCIATED STONE INDUSTRIES (KOTAH) LIMITED was incorporated on 17th January, 1945, the Company was initially established with the object of carry business of mining activities specially for Kotah Stone. Over the periods Company diversified its activities into energy sector etc.

The ASI INDUSTRIES LIMITED, proposed new name, is abbreviated of first letter of existing name i.e. Associated Stone Industries (Kotah) Limited. The Company popularly called ASI amongst the stakeholders and also have registered trade mark under class 19. ASI INDUSTRIES LIMITED, being a coined word bear a co-relation with the objective of the company. It is proposed to change the name of the company to “ASI INDUSTRIES LIMITED” being the coined word well associated with the line of activities carried out by the ASSOCIATED STONE INDUSTRIES (KOTAH) LIMITED.
